Territorial Scope

This prize-based event will take place on the national territory, in the 12 valleys participating in the FEDERCONSORZI DOLOMITI SUPERSKI, namely

Recipients

The competition is open to all skiers who:

- Purchase ski passes of any type from 15/11/2019 to 03/05/2020, with the exception of points value cards;
- then register on the site <http://www.dolomitisuperski.com> in the MyDolomiti section by matching their profile with the previously purchased ski pass and will make and keep their MyDolomiti profile public to 03/05/2020;
- have reached the age of majority.

Products subject of the promotion

The promotion covers ski passes of any type (excluding points value cards), valid in the Dolomiti Superski area from 15.11.2019 to 03.05.2020.

Ski passes reserved for professional categories (e.g. ski instructors), ski passes issued free of charge (gifts) and points value cards are excluded and will therefore not be considered for the purposes of this competition.

PrizesLevel 1 - Legend:

- 15 Dolomiti Superski seasonal ski passes valid during the 2020/21 winter season of the average market value of € 850.00 (VAT included) each.

Level 2 - Expert:

- 1 stay in Parkhotel Sole Paradiso (breakfast service) + 2 3-day ski passes with a total value of € 1,180.00 (VAT included)
- 1 stay in Boutique & Gourmet Hotel Orso Grigio (half board) + 2 3-day ski passes for a total value of € 1,160.00 (VAT included)
- 1 stay in Paula Wiesinger Appartements (breakfast service) + 2 3-day ski passes with a total value of € 980.00 (VAT included)
- 1 stay in Hotel Valgranda (half board) + 2 3-day ski passes with a total value of € 920.00 (VAT included)
- 1 stay in Suite Hotel Castelir (breakfast service) + 2 3-day ski passes for a total value of € 890,00 (VAT included)

It is specified that:

- The stays are valid during the 2020-21 winter season for 2 persons for 4 days/3 nights and include 2 adult 3-day Dolomiti Superski 2020/21 ski passes to be used during the period of stay.
- The place of stay must be reached by own means of transport.
- Stays must be used by and no later than 30 March 2021, with the exception of: Christmas, New Year, Carnival, November 1st and possible other periods foreseen by each facility, in addition to their periods of closure and subject to availability. The winner must agree on the period with the facility as soon as possible.
- The prize is non-transferable and, if not used, does not entitle to any cash compensation.
- The sponsor declines all responsibility for any problem of access, impediment, dysfunction or difficulty that may prevent users from accessing the service and/or participating in the competition.

Level 3- Rookie:

- 2 MOUNTAINFORCE ski suits (jacket + trousers) with an average market value of € 1,228.00 (including VAT) each.

It is specified that:

- Winners will be notified of the available sizes to choose from after the final draw.

The value of the prizes is to be understood as at the date of drafting of these regulations.

HOW TO PARTICIPATE

To take part in the competition, you must purchase any type of ski pass highlighted under "Sponsored products", register and associate the number of the ski pass purchased with your personal profile in the MyDolomiti section on the website <http://www.dolomitisuperski.com>:

- Filling out a specific form and providing the following data: name and surname, e-mail address, nationality, gender and date of birth, if not already registered;
- Issuing acceptance of these rules and consenting to the processing of personal data.

Without the completion of the registration procedure in the MyDolomiti personal area and without the combination of at least one of the aforementioned ski passes, the Sponsor will not be able to track the ski lifts used by the skier and therefore it will not be possible to participate in the Competition.

Several personal ski passes can be combined in the profile saved in the MyDolomiti personal area (e.g.: the skier can combine several ski passes belonging only to the skier himself: e.g. several weekly ski passes or several daily ski passes). The condition for participation in the competition is to have a personal profile.

To participate in the final draw, it will be necessary to reach one or more levels, based on the number of installations used, the number of days and the valleys reached according to the outline below with different draws and prizes for

each level reached:

1. LEVEL LEGEND: 12 valleys, 24 days, 120 different lift facilities
2. EXPERT LEVEL: 6 valleys, 12 days, 80 different lift facilities
3. ROOKIE LEVEL: 3 valleys, 6 days, 40 different lift facilities

It is specified that:

- Each recipient will become part of only one of the 3 categories listed
- Without the completion of the registration procedure in the MyDolomiti personal area and without the combination of at least one ski pass of the types listed above, it will not be possible for the Sponsoring Company to track the lift facilities used by the skier and therefore it will not be possible to participate in this competition.
- In order to count the number of lift facilities used, please remember that the lift facilities always count as no.1 (one) and even if the route of the lift facility includes an intermediate station or the return, only the access from the valley station of the plant will be counted.
- Passages not registered at turnstiles due to force majeure (e.g. temporary failure at the turnstile, so that it is decided - also for safety reasons - to keep the passage open) are excluded from the calculation.
- Any abnormal and/or unjustified use of the ski passes and the accumulation procedures indicated in these Regulations will entitle the Sponsoring Company to block, without any notice, the participants for whom abnormal and/or unjustified uploads have been found, as well as the delivery of the prizes. Any passages accumulated through abnormal and/or unjustified uploads will be irreparably lost and the relative behaviors will be punishable by law (abnormal and/or unjustified combinations are, for example but not limited to, the combination with a MyDolomiti profile of a daily ski pass and a weekly ski pass that overlap during the same period of use).
- Users who enter incomplete, incorrect data and/or register several times even through aliases or pseudonyms, will be excluded from participation in the competition.
- In case of multiple registration of a competitor, only one registration will be valid. Every scam attempt and incorrect, partial or false declaration entails the immediate disqualification of the participant.

FINAL DRAW

Those eligible will be identified by means of the software for control of transits at the entrances and turnstiles, at the end of the ski season. According to the number of valleys, days and lift facilities taken, recipients will be divided into 3 databases (LEGEND, EXPERT, ROOKIE), in relation to the ski performance recorded during the period from 15 November 2019 to 03 May 2020, after verification of the ski pass and participants data.

During the final draw, to be held in the presence of a public official in charge of consumer protection or a notary public by 31 July 2020, we will proceed to draw, absolutely at random, from each of the 3 databases mentioned above:

From LEVEL 1 - LEGEND database: 15 winning names, one for each prize, and 15 reserve names

From LEVEL 2 - EXPERT database: 11 winning names, one for each prize, and 11 reserve names

From LEVEL 3 - ROOKIE database: 19 winning names, one for each prize, and 19 reserve names

Communication and validation of the win

Winners will be contacted by e-mail.
